AGE

- I am 18 years of age or older.

FUNDRAISING GOALS

- As a Team BKS rider, I pledge to raise a **minimum of \$1000.00** to support the children and families served by Brooklyn Kindergarten Society (BKS). Funds must be collected by me, on or before May 3, 2020. The minimum fundraising pledge will be guaranteed with the credit card noted below.
- If the minimum goal is not reached by May 3, 2020, I authorize the difference to be charged to the credit card below listed on the application. If I have met the fundraising minimum, then nothing will be charged to the credit card. I understand that all donations are tax-deductible to the extent allowed by law.
- In the event that I should withdraw from the 2020 TD Bank Five Boro Bike Tour, I understand that I am still responsible to raise the minimum fundraising amount of \$1000.00.
- If the race cannot be held for any unforeseen circumstance, any funds raised by me will not be refunded.
